CALL TO ORDER & ROLL CALL: Supervisor Dennis Reboletti called the Regular Meeting of the Board of Town Trustees to order at 6:30 P.M. The Pledge of Allegiance was said by all present. DIVISION REPORTS:

HIGHWAY DEPARTMENT: Highway Commissioner Holod reported on the following.

- Nick Fuller from the Du Page County Forest Preserve assessed the health and the progress of our pollinator garden. He stated it looked good, and no need to be concerned with the weed growth.
- Sold 5 rain barrels in May and continue to receive calls inquiring about rain barrels.
- In March, we sponsored 198 bus and taxi rides with the Ride DuPage program.
- The speed cart from The Du Page County Sheriff's Department was placed in the Army Trail Estates Subdivision and the Avenues to address cars speeding in the area.
- Submitted the MFT request form to the county for salt purchase for this winter season. Ordered 800 tons of salt for a total of \$64,904.00.
- We enlisted the help of the DuPage County Stormwater Management Department to repair a sinkhole in the Army Trail Estates subdivision. They came out with their camera truck and provided support in the repair of the sinkhole. The shared services with the county were less labor intensive and performed at a very reasonable cost.

TOWN CLERK: Clerk Moretti reported on the following.

- Attended the Knights of Columbus brunch and accepted a check on behalf of the Addison Township Foundation for the food pantry.

SUPERVISOR/TREASURER: Supervisor Reboletti reported on the following.

- Many improvements have been made to the building in the last 4 years. Under consideration is the repair of a section of the roof on the Oak Street side of the building.
- June 10th we will host the Addison Intergovernmental meeting in the Event Center.
- On June 24th we will host the caseworkers meeting; their supervisors are invited as well.
- We are still averaging about 100 to 150 families a week using the food pantry.


OLD BUSINESS: None


