RECITALS

WHEREAS, the Township of Addison, DuPage County, Illinois, (the “Township”) is a township duly organized and existing under Constitution and the laws of the State of Illinois;

WHEREAS, pursuant to 10 ILCS 5/28-2 and 60 ILCS 1/80-80, the Township Board of Trustees, by Resolution, is authorized to submit to the electors of the Township at a regularly scheduled election an advisory public question;

WHEREAS, the Township Board of Trustees hereby deems it advisable and in the best interests of the Township to submit to the voters of the Township an advisory public question whether the state of Illinois should create an independent citizens commission to draw fair and competitive federal and state redistricting maps, rather than allowing lawmakers to decide;

WHEREAS, the Township Board of Trustees hereby deems it advisable and in the best interests of the Township to submit the advisory public question at the April 1, 2025 primary election.

NOW THEREFORE, BE IT RESOLVED by the Board of Trustees of Addison Township, DuPage County, Illinois, as follows:

Section 1: The foregoing Recitals are true and correct, and said Recitals are incorporated herein as if written out here in full.

Section 2: The Addison Township Board of Trustees hereby authorizes the following advisory public question (the “Advisory Public Question”) to be placed on the ballot and submitted to the voters of the Township at the Consolidated Election to be held on April 1, 2025 (the “Election”), in substantially the following form and in accordance with the general election laws of Illinois:

Section 3: The Addison Township Board of Trustees further authorizes and directs that the Advisory Public Question be certified to the proper Election Authority and official(s) so that the question may be submitted to the voters of Addison Township at the Election in accordance with the general election law of Illinois.

Section 4 The Election shall be held in the voting precincts and at the polling places established in accordance with the general election laws of the State of Illinois by the Election Authority for voters of the Township at the Election.

Section 5: That after adoption hereof and not less than sixty-eight (68) days prior to the Election, the Addison Township Clerk shall certify a copy hereof to the DuPage County Clerk, or any Election Authority having jurisdiction over Addison Township, in order that the Advisory Public Question may be submitted to the voters of Addison Township at the Election.

Section 6: That Notice of the Election (the “Notice”) shall be given in accordance with the general election laws of the State of Illinois by the Election Authority in compliance with Section 12-5 of the Election Code of the State of Illinois, as amended (10 ILCS 5/12-5).

Section 7: That not less than ten (10) days before the date of the Election, the Clerk of the Board shall post a copy of the Notice at the principal place of the Township.

Section 8: That the ballot to be used at the Election shall be in substantially the following form, with such alterations, changes, deletions and insertions as required by Articles 24A, 24B, 24C, or other provisions of the Election Code if an electronic, mechanical or electric voting system is used at the Election:
